## LEOSA/HR218 PROCESS:

ILEA staff have been working hard over the last couple months to implement a standardized process to ensure qualified, retired LEO's meet the federal requirements for protection under the Law Enforcement Officers Safety Act (LEOSA).

A cover sheet detailing the process and required forms can be found on the ILEA website and in the Document Library of your Acadis portal. To summarize, the agency questionnaire needs to be submitted to ILEA one time for each qualified, retired LEO. The qualified, retired individual questionnaire and documentation of successful qualification needs to be submitted to ILEA annually. An active ILEA approved firearms instructor needs to administer the qualification. The ILEA Off-Duty/LEOSA and Handgun Qualification courses are approved courses of fire. Instructors can access HR218 cards through the Acadis portal Document Library to sign and provide successful qualifiers.

ILEA will update our internal records to reflect HR218 compliance once the required documentation is received.

ILEA HR 218 Process



### Please Review Your Agency's Roster ....via the Acadis Portal

The beginning of the year brings a lot of changes to agency rosters with elections, new hires and retirements. Please take just a moment to review your agency's roster and submit the appropriate separation notice(s) via the Acadis portal to reflect any updates. Your assistance is greatly appreciated to help ensure our records are accurate. Additionally, there is no better time to check expiration dates for ILEA Instructor endorsements.



# **MMPI UPDATE**

Effective January 1, 2025 participating cities in the Municipal Fire and Police Retirement System of Iowa (MFPRSI) will exclusively use the MMMPI-3 (police version) in conjunction with a required interview to meet the psychological evaluation require-

ment set forth in 501-2.(2) (80B). This change is a result of House File 2680 from the most recent legislative session.

Agencies not covered by MFPRSI will continue using the MMPI-2 as required by 501-2.2(2).

When utilizing ILEA testing services, a hiring authority should submit an MMPI Order Form via the <u>acadis portal</u>. The MMPI Order Form has been updated to include MMPI-3 (police) as a selection. Additionally, the order form includes MMPI-3 (correctional officer) and MMPI-3 (dispatcher) that may be ordered by hiring authorities who choose to adopt a higher standard than what is currently required for those positions. All versions of the MMPI-3 contain 335 questions and take applicants about 40 minutes to complete.

If an agency chooses to use a local clinic to administer testing to LEO applicants; a <u>Clinic Results Form</u> must be completed by the licensed professional and faxed or emailed, along with the raw data and evaluation, to ILEA for every tested applicant, hired or not. If you use a local clinic, ensure they are aware of the process outlined in this paragraph.

### **TASER INSTRUCTORS**

Axon sent out a training advisory on October 2nd, 2024 that they won't be hosting additional Taser Instructor Courses until after March 31, 2025. In the training advisory, Axon stated, "To ensure uninterrupted delivery of agency operator courses by currently certified instructors, Axon Training is implementing the following change: Axon Training is extending current certified Instructors through June 30, 2025. **This effects only Axon Training sponsored courses.**"

ILEA has updated our records to mirror Axon's training advisory for TASER instructor's expiring from October 2nd, 2024 through June 30, 2025. For those impacted by Axon's extension, our records will reflect your TASER instructor certification expiring on June 30, 2025 unless you send us notification of renewal/extension prior to that date.
