A NOTE FROM DIRECTOR CARNEY

As we head into summer, ILEA Basic Academy Classes 321 and 322 have a total of 78 recruits who are in week 5 of 16. They have been on the move a lot and have been working extremely hard.

I had the opportunity to attend the Western Iowa Tech Regional Academy's 36th graduation in Sioux City earlier this month where 13 new law enforcement professionals from across the State received their certification. WIT Regional Academy Director Dave Drew was also celebrated after 39 years in law enforcement and 5 years as the Director at WIT. Dave is retiring at the end of June, and we wish him well.

HOUSE FILE 901

Governor Reynolds recently signed this bill that will take effect on July 1, 2025. This bill does a couple things:

- Removes the restrictive "in this state" language as it applies to successful completion of a two-year or four-year criminal justice and police science program at an accredited education institution for eligibility to attend a level II academy.
- Allows military veterans and federal LEO's who meet certain conditions to apply to earn Iowa Peace Officer certification through the established reciprocity process.
 - Generally, the conditions are four years of active duty service as a military police officer in the Army or equivalent in other branches, four years of service for federal LEO's, application for reciprocity within three years of applicable service, honorable discharge/good standing and successful completion of accredited training that is equivalent to or exceeds Academy standards.
- If the Academy Council does not approve the individual for the reciprocity process, the Academy Council may consider the applicant for entry into a level II academy.
